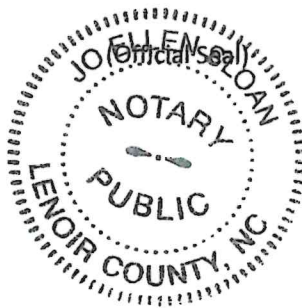

## CHALLENGER STATEMENT

Dear Board Members,

I am filing a formal complaint issuing a candidate challenge against Michael Horne, who has filed with the Lenoir County Board of Elections to be a candidate for Mayor in the Town of Pink Hill. You are in receipt of the official signed and notarized Candidate Challenge Form. I have also supplied the Board with documentation to support this challenge. In this statement, I will outline the reasons for the challenge and the reasons why he should be ruled ineligible to be a candidate.

Michael Horne is a resident of Cape Carteret, NC. His primary residence is at 253 STAR HILL DR CAPE CARTERET, NC 28584. I have supplied photos of his home in the supporting documentation emailed to your office. According to property records, he moved to this home in or around 2017 and has made continual improvements to the property that are documented in supplied property records and in the supporting material where he has documented these life moments on social media.

He now claims legal domicile for voter registration purposes and to qualify to run for office in Pink Hill at 201 E LYNWOOD AVE PINK HILL, NC 28572. The dwelling he describes as his domicile is a small apartment above a house. He registered at this address on May 3, 2023. I have included photos documenting the property.

According to North Carolina law, when a candidate challenge takes place, the burden is placed on the candidate - not the challenger - to show by a preponderance of the evidence that he or she is qualified to be a candidate for the office.

If the challenge is based upon a question of residency, § 163-127.5 (b) places the burden of proof on the candidate, who must show all of the following:

- (1) An actual abandonment of the first domicile, coupled with an intent not to return to the first domicile.
- (2) The acquisition of a new domicile by actual residence at another place.
- (3) The intent of making the newer domicile a permanent domicile.

Mr. Horne must provide this Board with substantial evidence to support a finding that he has met the residency requirement.

Substantial evidence is "such relevant evidence as a reasonable mind might accept as adequate to support a conclusion" and "is more than a scintilla or a permissible inference." *Lackey v. Dep't of Human Resources*, 306 N.C. 231, 238, 293 S.E.2d 171, 176 (1982).

A residence is a place a person occupies either temporarily or permanently, but a domicile is a permanent, established home where one intends to remain permanently or for an indefinite length of time unless an event happens to induce the person to leave.

Where someone retains his original home with all its incidental privileges and rights, there is no change in domicile. *Hall v. Wake County Bd. of Elections*, 280 N.C. 600, 605, 187 S.E.2d 52, 55 (1972); see N.C. Gen. Stat. § 163-57(3) (1991)

First, Mr. Horne still maintains the home in Cape Carteret. Nothing supports that he is selling the home or abandoning the home, or facing some change in life circumstances such as divorce. His wife also changed her registration to Pink Hill on May 8, 2023, so he is not living apart from his spouse based on her voter registration which means he is claiming they both live in this small apartment, not separately.

Second, the place he is using as his residence in Pink Hill has been in his family for decades. I understand his son lives in the property now with his family, and the part of the property Mr. Horne claims as his domicile is basically a small guest or rental apartment above the home with tall stairs to climb on the exterior to reach it. I have supplied a photo from Google Maps of that home, marking the apartment above the main part of the structure.

Third, there is nothing in his public utterances or his life that suggests he intends to make this his permanent domicile. He has made substantial improvements to the Cape Carteret property and retains all its incidental privileges and rights and nothing indicates he does not plan to return to that home.

It strains credulity for anyone to believe that Mr. Horne has made the small apartment in Pink Hill his legal domicile and abandoned and has no intent to return to the beautiful property in a golf club community in Cape Carteret.

Of course, Mr. Horne will articulate why this would be his domicile for reasons unrelated to his running for office. However, his intent matters. The burden on him is to prove he lives there. Actions and not statements demonstrate that. The fact you say you live somewhere is not what matters. What you do and how you live is what matters.

As the North Carolina Court of Appeals stated in *Farnsworth v. Jones*, 114 N.C. App. 182, 189 (1994), "We have not ignored defendant's declarations concerning his [residence]. We must point out, however, that conduct is of greater evidential value than expressions of intent."

I have supplied an ongoing stream of social media posts from Mr. Horne that are evidence of his conduct and his true intent and evidence of his legal domicile. When you read the posts, it is clear to any reasonable person that he views his domicile as the home in Cape Carteret.

In these social media posts, he will express feelings "at home in Cape Carteret." He will detail his love for his home in Cape Carteret. You can review the documentation provided, but here are examples of the things described in these posts:

- Voting in Cape Carteret in the 2020 and 2022 Federal elections. He shows in the post that both he and his wife voted in Cape Carteret.
- Rehab shoulder surgery exercise at a gym in Cape Carteret. This is an important point because Mr. Horne owns a gym in Pink Hill. Any reasonable person would assume if he lived in Pink Hill, he would do his rehab in Pink Hill at a gym he owns and not travel to a gym over an hour away that is owned by someone else.
- Celebrating life events such as birthdays, Father's Day, Mother's Day and Christmas, all at the home in Cape Carteret.
- He describes in detail the renovation of his garage to house his motorcycle collection and describes that his "garage is complete" and describes a new motorcycle he acquired as his "new work ride" which contemplates that the garage housing the bike is his home and he would ride the motorcycle to work and then back home. Home in Cape Carteret.

- In a comment section chatting with a person on Facebook that lives in the Cape Carteret area, the person mentions she has a problem with her lawn mower. Mr. Horne, who owns a lawn mower repair service, tells the woman he will bring a trailer "back home" from the store in Pink Hill. Nothing expresses his intent more than this. His own words show that his mindset is that Cape Carteret is his home, not Pink Hill.

I am confident the evidence presented shows his true legal domicile to be Cape Carteret. However, the preponderance of evidence standard in this instance requires less proof from the challenger. As stated earlier, the burden of proof is on Mr. Horne to prove he has moved to a new domicile, abandoned the first domicile and has no intent to return to the first domicile. That burden of proof is on him.

I cannot produce on my own all the documentation that would further document his legal domicile. However, if you remain unconvinced by his claims, I urge the Board to subpoena information such as income tax records, utility bills, utility bill usage, internet bills, internet usage, security camera footage from the two properties (if such footage exists), and other personal property and licensing records that would further bolster the fact that his home in Cape Carteret is his legal domicile.

In a Facebook post from Feb 18, 2021 Mr. Horne captions a photo of his Cape Carteret home with "My Hobby is my Family and My Yard and Home." As detailed in the supplied documentation, nothing has changed. Cape Carteret is his home unless he can prove to this Board otherwise.

I appreciate the Board of Elections taking this matter seriously. Our election laws were put in place to deter the abuse of the election process and to ensure candidates and elected officials live among the residents they represent.

I respectfully ask that you rule that Michael Horne is not a qualified voter in Pink Hill and Lenoir County and therefore is not qualified to run for any office in Pink Hill.
